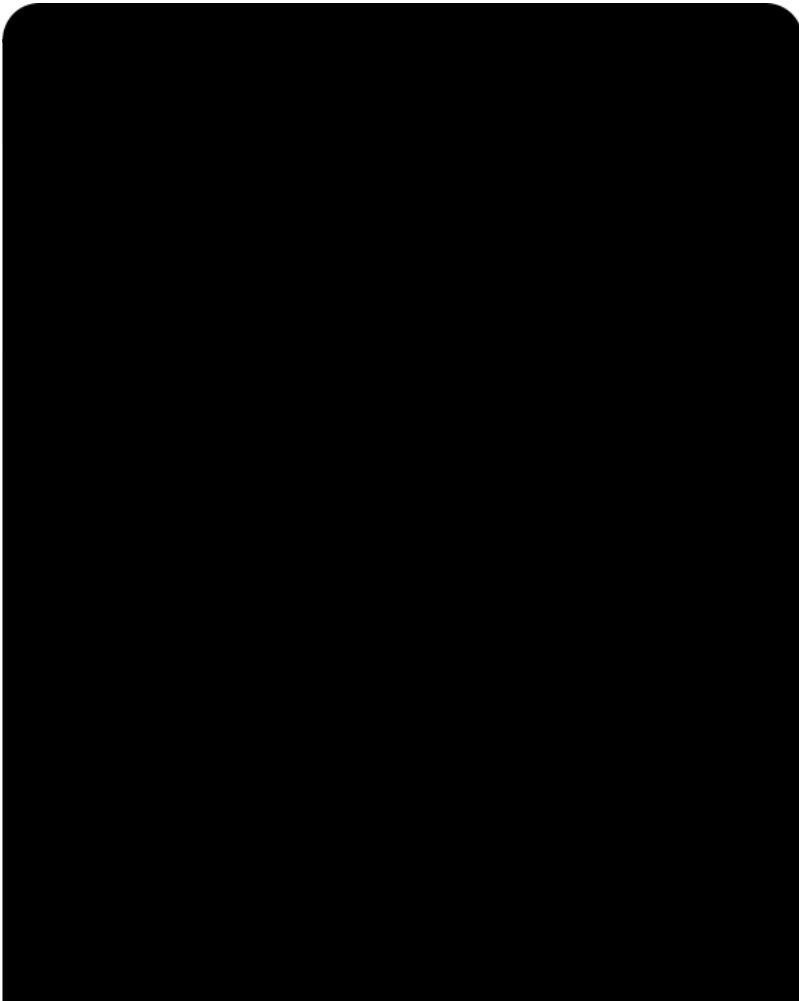

Do you record video or just audio?

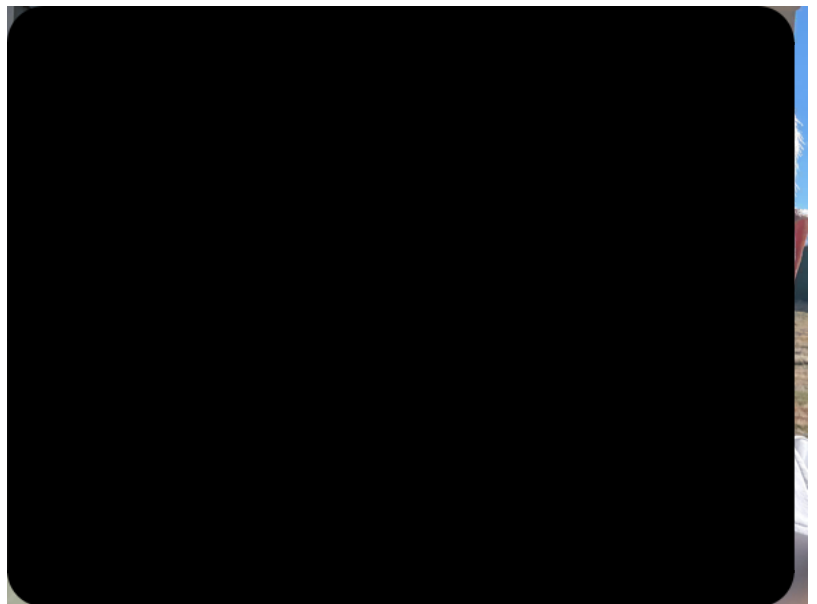
I was planning on both, but I have the flexibility to use either especially if you have a preference
